Pursuant to the provisions of the Federal Law on Protection of Personal Data Held by Private Parties and its Regulations, Grupo 365 is responsible for the processing of the personal data it collects, as well as for its use, protection, and safeguarding.

The personal data you provide to us will be used for the following purposes:

 - To manage and monitor entrusted foreign trade operations.
 - To provide updates on the status and progress of services rendered.
 - b) Secondary purposes
 - Send informational communications related to the services provided to clients and business partners.
 - Strengthen business relationships with clients and partners.

GRUPO 365 may transfer personal data to subsidiaries, affiliates, or related companies, as well as to entities with which it maintains business relationships related to foreign trade services, such as shipping agencies, carriers, stevedores, insurers, currency exchange bureaus, and other companies necessary for the provision of the service.

regarding the processing of their personal data, revoke the consent granted for such processing at any time and in writing, as well as request the restriction of the use or disclosure of their personal data when they consider that their data is not necessary for the purposes set forth in this Privacy Notice.
